Advocacy vs. Lobbying – What's the difference?

Advocacy is the act of speaking for, in support of, or on behalf of others. Lobbying is attempting to influence a politician or office holder on a policy or bill. PTAs can do both of these activities within IRS limits.

Our Founder: Washington State PTA was founded in April 1905 by Abby Williams Hill of Tacoma. She was an artist who saw a need for an organization to support Washington's children. Thanks to Abby's leadership and vision — and that of thousands of parents and teachers who have carried her vision forward — Washington State PTA has been a leading voice for children and families in the state ever since.



WSPTA Advocacy Positions

WSPTA positions include issues, principles and resolutions, which are voted on by our membership.



- Legislative issues make up our legislative platform, which is a short-term, two-year platform made up of the top five issues and also supported issues. The top five are the primary focus when advocating throughout the year.
- **Resolutions** are specific, long-term positions that guide the advocacy work from the local level to the state level. They are typically broader in scope than legislative issues.
- Legislative principles are long-term and consist of five overarching categories. Principles fill the gaps in the short-term issues platform so that members can advocate on emerging issues.

2025 Friend of Children Award: Senator Lisa Wellman

The Friend of Children Award recognizes an individual or organization for state-level dedication to all children through service aligned with WSPTA's vision and mission.

Sen. Wellman, is a tireless advocate for children, continuing to look at how to improve the current system and make sure that parents and students have access and funding to the best public school system possible.

Sen. Wellman has been a staunch ally for Washington's children, ensuring investments in early learning, stability in K-12 funding, and encouraging affordable access to higher education. She has taken her early roots in teaching and translated them into a passion for student success. Her contributions include ground-breaking work in career-connected learning and competency-based learning. As a former executive in the technology industry, Senator Wellman is committed to providing all students with access to computer science courses to fill the various tech jobs offered across the state.

Sen. Wellman has been a friend to WSPTA since arriving in the State Senate in 2017, working closely with the organization on legislation and making herself available throughout the year to meet with members, advocates, and leadership.

2025 Friend of Children Award: Be SMART for Kids Washington

For those of you unfamiliar with the Be SMART campaign, it was launched to raise awareness that secure gun storage—storing guns unloaded, locked, and separate from ammunition—can save children's lives. Be SMART emphasizes that it's an adult responsibility to keep kids from accessing guns, and that every adult can play a role in keeping kids and communities safer.

This non-partisan, non-political approach engages both gun owners and non-gun owners in working together to make our communities safer. And this work, like PTA, is volunteer-driven. In Washington, Be SMART volunteers have spent countless hours tabling at community events like Washington State PTA Convention and Legislative Assembly, providing free information sessions to PTAs and other groups to help convey these lifesaving messages, normalize conversations around gun storage, and provide PTA leaders with the tools they need to share this message with others in their community.



2025 Outstanding Advocate Award: Natayla Yudkovsky

The Outstanding Advocate Award recognizes an individual for their statewide advocacy and commitment in helping to create strong policies relating to the health, welfare, safety and education of children and youth.

Natalya is an amazing advocate because she is smart, compassionate, and great at keeping calm and gracefully navigating highly charged issues and environments. She mentors people and shares the thought process and best practices behind her actions which builds bridges and empowers new advocates.

On the advocacy committee, Natalya has a keen ability to review bills, see different perspectives, and articulate why PTA should support important pieces of legislation. She is a fierce advocate for graduation credits and pathways, but does not just focus on a single issue. She is willing to dig in and do the research to help craft Washington State PTA issues and resolutions. When we need a person to testify, look no further. She can be asked to testify on nearly any topic and provide a thoughtful perspective on how students would be impacted.

It is also important to spotlight how Natalya consistently and passionately speaks up when she feels there is not a perspective being heard or she sees something that is not right. She often uses her voice for those who cannot be in the room and whose voices cannot be heard.

2025 Outstanding Student Advocate Award: Taanvi Arekapudi

The Outstanding Student Advocate Award recognizes a student for statewide advocacy, leadership and/or service on behalf of all children and youth.

Taanvi has been advocating for years and has advanced to become an author, keynote speaker, and mental health advocate. Her mission is to help kids and teens "embrace their uniqueness, harnessing their strength, and realizing their worth, no matter what society says...to shatter the mental health stigma."

Taanvi Arekapudi is an international bestselling author of "Uplift Teens Today" (the first teento-teen mental health book), creator of the Emotion Cards Deck, and founder of the award-winning, revolutionary 24/7 platform, Nexus: Mental Health Hub for Schoolss. Nexus has impacted over 800k individuals, with a goal to reach over 80 million students nationwide.

WSPTA 2025 Awards of Excellence: Advocacy

The purpose of this award is to promote advocacy at local PTAs, community PTAs, and councils by recognizing programs, projects, and activities/events that increase awareness of and participation in advocacy issues at the school, local community, council, region, state, and national levels. Congratulations to the 2025 Gold Level Winners!

Bellevue Council PTA - Worked together with their community to create a town hall around funding gaps in education. This town hall event originated from conversations between the Bellevue school board directors and Bellevue PTSA Council. They heard that education associations and school district leaders in Shoreline, Northshore and Edmonds did a joint town hall in October that was very well attended. Bellevue Council PTSA wanted to host a town hall for the five Eastside school district communities as they all have a vested interest in closing the funding gap. The town hall had over 700 people attend the event from the Eastside, including legislators, students, district administrators, school board members, parents, and community members!

Everett Council PTA - The voter registration drive was initiated to educate and encourage eligible high school students about the importance of voting and civic engagement. Recognizing the need to empower students to use their voices in the democratic process, the goal was to organize an event before the voter registration deadline for the November 2024 elections. The Everett PTSA Council Advocacy and FACE chairs collaborated with the Snohomish County Voter Office, Mill Creek YMCA Youth and Government students from Jackson High School, and local PTSA leaders to coordinate this event. The drive aimed to serve all Jackson High School and Everett High School students aged 16 or older who were not yet registered to vote, providing them with an opportunity to register or pre-register and learn about the importance of civic participation.
